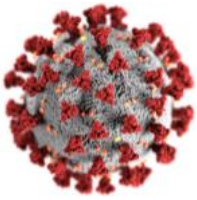

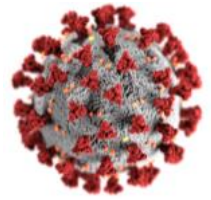
**There were 43 patients enrolled into LOVIT in October and 32 in November.**
