We are pleased to inform you that the per participant payments for patients enrolled on or after March 11, 2020 will be increased to offset the additional work flow. We acknowledge that patient enrollment during the pandemic requires more time and that the recent changes in the database also require additional time to update data previously entered (please see the next section). This is our way to thank you for all the work you do.

COVID-19 STATUS AT RANDOMIZATION

For all future patients randomized in LOVIT, during the 24 hours following the randomization, please answer question 8 on form 3.2 which asks about the COVID-19 status of the participant at baseline. This will help us to keep track of the status of COVID-19 patients.

CHANGES IN THE DATABASE – FORMS 3.2 and 5

1- Form 3.2, question 8 and Form 5, question 1.1.

Please answer these questions for all participants randomized on or after January 25, 2020. For the patients randomized before January 25, 2020, the 'Not applicable' option has been checked automatically. We chose January 25, 2020 as the cut-off, as the first patient with COVID-19 was diagnosed in Canada on that date.

2- Form 5, question 7

For participants with the response option 'Alive' checked, please enter data for questions 7.2 and 7.3. For participants with the answer 'Presumed alive because discharged alive before day 28' checked, please enter data for questions 7.1, 7.2, and 7.3. If you don't have the answer for 7.2 and 7.3, please enter the missing code (in the left corner of the screen click on the 3 dots and click missing) and type 'Data not available' for the reason in the data value box at the left corner of your screen.

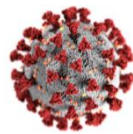

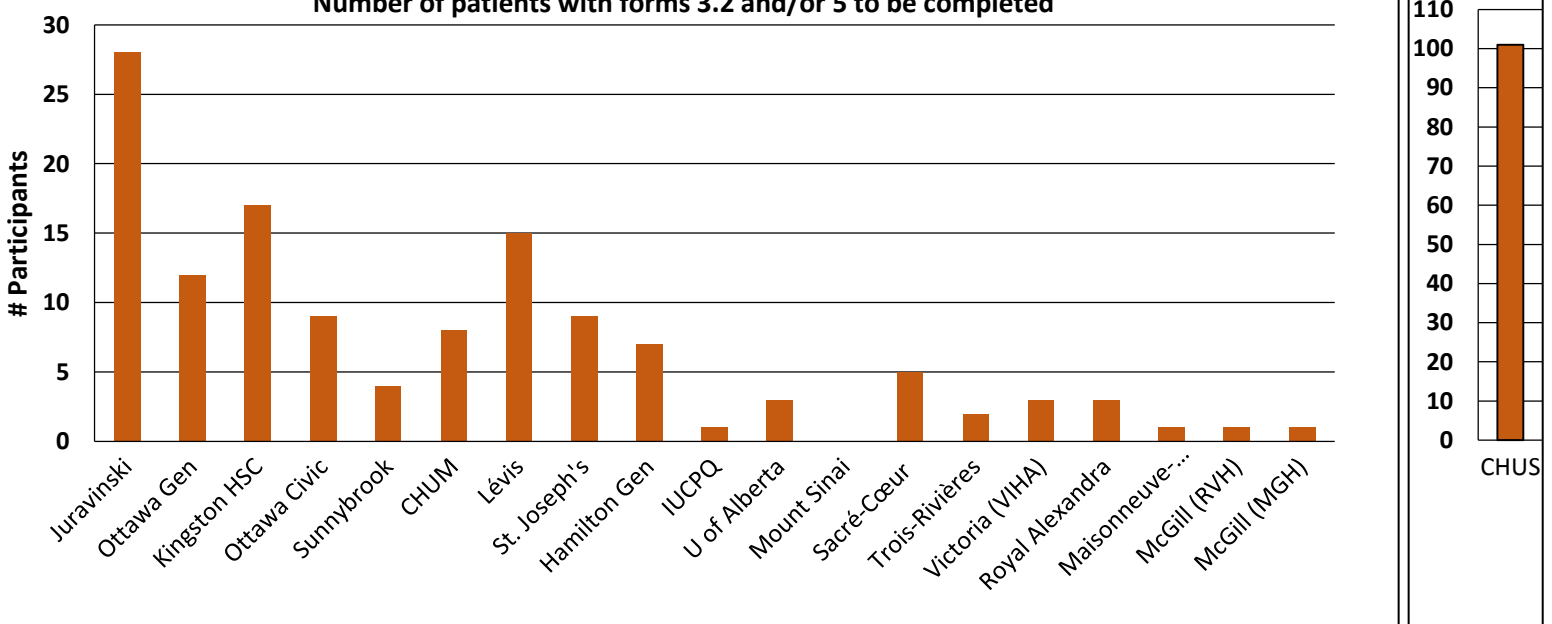

Data Validation Summary by Site (as of May 4, 2020)



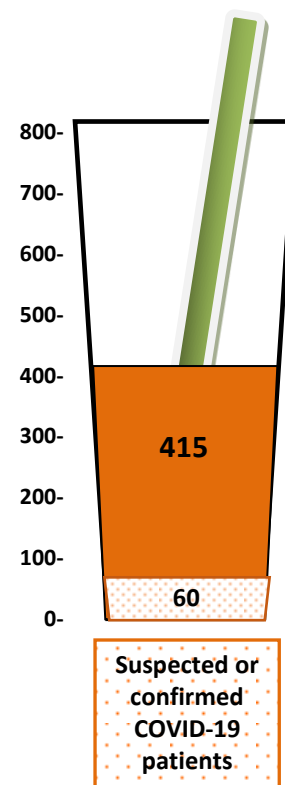
